A BILL

To authorize additional district judges for certain district courts and convert temporary judgeships, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “District Court Judge-
5 ships Act of 2021”.

1 **SEC. 2. ADDITIONAL DISTRICT JUDGES FOR THE DISTRICT**
2 **COURTS.**

3 (a) **ADDITIONAL JUDGESHIPS.**—The President shall
4 appoint, by and with the advice and consent of the Sen-
5 ate—

3 (b) CONVERSION OF TEMPORARY JUDGESHIPS.—The
4 existing judgeships for the district of Kansas and the east-
5 ern district of Missouri, authorized by section 203(e) of
6 the Judicial Improvements Act of 1990 (Public Law 101–
7 650; 28 U.S.C. 133 note), and the existing judgeships for
8 the northern district of Alabama, district of Arizona, the
9 central district of California, the southern district of Flor-
10 ida, the district of New Mexico, the western district of
11 North Carolina, and the eastern district of Texas, author-
12 ized by section 312(e) of the 21st Century Department
13 of Justice Appropriations Authorization Act (Public Law
14 107–273; 28 U.S.C. 133 note), shall be authorized under
15 section 133 of title 28, United States Code, as amended
16 by this Act, and the incumbents in those offices shall hold
17 the office under such section.

18 (c) TECHNICAL AND CONFORMING AMENDMENTS.—
19 In order that the table contained in section 133 of title
20 28, United States Code, will, with respect to each judicial
21 district, reflect the changes in the total number of perma-
22 nent district judgeships authorized as a result of sub-
23 sections (a) and (b) of this section, such table is amend-
